## BREEDING CONTRACT

This contract for the breeding season of 20\_\_\_\_\_, is made and entered into on this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_, is by and between Walker Training Stables, Inc., herein after designated Stallion Owner, and \_\_\_\_\_, herein after designated Mare Owner. Mare Owner agrees to breed the mare, \_\_\_\_\_, Reg. No. \_\_\_\_\_ for the fee of \$500.00, to the stallion, Ima Dirty Teddy, APHA Reg. No. 265,928 subject to the following conditions:

1. Breeding season shall be from February 1 thru July 15. Approximate date of mare's arrival will be \_\_\_\_\_.

### Live Cover

2. Stallion service fee of \$500.00 plus any other expenses are to be paid when the mare is picked up or when the mare owner is invoiced, whichever is first. Mare Owner will give Stallion Owner 48 hours notice before removing mare, so that invoice may be prepared.
3. A copy of the mare's registration papers (both sides) and a veterinarian's health certificate, including uterine culture, worming, current Coggins test and immunization records, shall accompany the mare upon arrival at Walker Training Stables. The board bill will be \$10/day dry and \$14/day wet. This must be paid when the mare is picked up from the stable.
4. Stallion Owner assumes responsibility for arranging veterinary and farrier care as deemed necessary for the health and safety of the mare and/or foal. Such expenses will be paid by Mare Owner.
5. Both parties agree that Stallion Owner is not liable for death, sickness and/or accident to the mare and/or foal. Mare Owner is not responsible for any accident or injury to the stallion. Responsibility for insurance passes to the Mare Owner with this contract. Mare Owner agrees to look solely to his/her insurance for compensation for any loss, including, but not limited to the semen, shipping container and the mare Owner's horse.

### Shipped Semen

6. The stallion service fee of \$500 **plus shipped semen fee** must be paid and a signed and dated contract received by the stallion owner **prior to the shipment of semen**. Shipped semen is \$250/per FedEx shipment (if requesting counter to counter add \$100). A photocopy of the mares papers must be returned with this contract as well as a negative culture signed by your veterinarian.
7. 24 hours advance notice is required to collect semen. You must also notify us when your mare begins to come in heat in order for us to know to be expecting the semen call.
8. If mare does not settle with the first shipment, there will be a charge of \$250 for each additional shipment. The Stallion Owner agrees to diligently try to settle the mare, however, the Stallion Owner is to be held harmless if such efforts do not get the mare in foal. Walker Training Stables, Inc. employs Stallion Services Breeding

Management to give the best possible advantage in conception rates. Stallion Services is available 7 days a week for semen shipment and has 18 years of expertise in the commercial horse breeding industry.

### **Live Foal Guarantee**

9. Stallion Owner offers a Live Foal Guarantee. If the mare proves barren, aborts her foal, produces a stillborn foal or produces a live foal that is unable to stand alone and nurse without assistance, Mare Owner shall be entitled to a return service the following year and the stud fee will be carried forward. The Live Foal Guarantee is valid only if the mare owner has properly maintained the health of the mare, and verifies the mare's pregnancy loss by providing the Stallion Owner with a signed and dated veterinary certificate, clearly verifying the loss of said foal and verifying that in the veterinarians judgment, the mare was maintained in good health, including all vaccinations and dewormings as recommended by the veterinarian, including but not limited to Rhino vaccinations. The Stallion Owner must receive this certificate within 30 days of the loss of the mare's pregnancy and before said mare is rebred.

### **Unable to Breed**

10. If the above stallion should die or become unfit for service the stud fee and shipped semen fee will be refunded.
11. If the above mare should die or become unfit for breeding the stud fee and shipped semen fee will be refunded or a substitution of another mare may be done with the consent of the Stallion Owner. If the mare changes ownership, this contract is nullified and will not be eligible for a rebreed.

### **Breeder's Certificate**

12. A Breeder's Certificate shall be issued by Stallion Owner for the foal conceived by this mating when Mare Owner has paid stud fee and all other expenses, and after Mare Owner has notified Stallion Owner that mare has produced a live foal.

### **Legal**

13. This contract is non-assignable and non-transferable.
14. This contract is entered into the State of Ohio , and will be interpreted and enforced under the laws of Ohio. If any clause in the contract is against Ohio law, then that clause shall be null and void.
15. This contract represents the entire agreement between the parties. No other agreements, promises, verbal or implied, are included unless specifically stated in the written Contract. The original contract will be kept on file at Walker Training Stables, Inc. and a copy provided for Mare Owner. When Mare Owner and Stallion Owner have signed this contract, it will then be binding on both parties, subject to the above terms and conditions.
